IX. STAFF REPORTS

- A. Maintenance Foreman:
 - Doug Freer reported the Maintenance Dept. has switched everything over and are ready for winter. Mr. Baughman wanted to express his appreciation for the Maintenance Dept. going around and cleaning up the leaves away from the storm sewer grates. He also asked if the Borough could look into purchasing a leaf vacuum machine, similar to what the City of Franklin has, so the residents wouldn't have to rake the leaves up, bag them and bring them over to the Borough building.  - 4. Mr. Sporer informed Council that the Borough was approved for \$25,000 in County Liquid Fuels Funds. The funds will be used to replaced the third culvert pipe along Shaffer Run Road.
