TO ALL INTERESTED AGENCIES, GROUPS AND PERSONS:

This notice shall satisfy two separate but related procedural requirements for the activities to be undertaken by the County of Venango.

Request for Release of funds:

On or about December 14, 2020, the above-named Grantee will request that the Department of Community and Economic Development (DCED) release funds for the FFY2016 CDBG funds for the following project:

**FFY 2016 CDBG Sugarcreek Housing Rehabilitation Program:**

**Total: \$59,787.09**

Sugarcreek Borough proposes to use the Community Development Block Grant Program funds to perform rehabilitation on a case by case basis for owner-occupied homes in the Sugarcreek Borough area. A Housing Market Study completed in 2009 by czbLLC that encompassed all of Venango County specifically addressed the need for rehabilitation of owner-occupied homes. One of the goals that stemmed from the study was to facilitate both small- and large-scale repairs, focusing on senior, low-income, and handicapped households. The Housing Market Study noted that there were homes in need of repairs in the same neighborhoods as homes that had been well maintained. In accordance with 58.15, a tiered review process has been structured for the unidentified scattered sites. Anticipated activities included in this project are limited to rehabilitation when the facilities and improvements are in place and will be retained in the same use without change in size or capacity of more than 20 percent. By providing the needed repairs through the CDBG grant, the values of both the rehabilitated homes as well as the homes surrounding them will increase. The total CDBG Program funds requested for this project is \$59,787.09.

### FINDING OF NO SIGNIFICANT IMPACT

It has been determined that such Request for Release of Funds will not constitute an action significantly affecting the quality of the human environment and accordingly the above-named Grantee has decided not to prepare an Environmental Impact Statement under the National Environmental Policy Act of 1969 (PL 91-190). The reason for the decision not to prepare an Environmental Impact Statement is as follows:

The activities were determined to present no significant adverse impact upon the environment.

#### PUBLIC COMMENT ON FINDINGS

All interested agencies, groups and persons disagreeing with this decision are invited to submit written comments for consideration by the Grantee to the Venango County Regional Planning Commission, 1168 Liberty Street PO Box 831. Such written comments must be received **on or before December 11, 2020**. Comments shall specify which part of the notice they are addressing. All such comments so received will be considered and the Grantee will not request the release of SCP funds or take any administrative action on the above named projects prior to the date specified in the preceding sentence.

#### ENVIRONMENTAL CERTIFICATION

Venango County also certifies to DCED that Michael C. Delaney, County Commissioner, consents to accept the jurisdiction of the Federal Courts if an action is brought to enforce responsibilities in relation to Environmental Reviews, decision making and action; and that these responsibilities have been satisfied. DCED's approval of the certification satisfies its responsibilities under the National Environmental Policy Act of 1969 and related laws and authorities, and allows Venango County to use program funds.

#### OBJECTIONS TO RELEASE OF FUNDS

***DCED will accept objections to its release of funds for Venango County's certification for a period of fifteen days following the anticipated submission date or its actual receipt of the request (whichever is later) only if they are on one of the following bases: (a) the certification was not executed by the Certifying Officer of Venango County; (b) Venango County has omitted a step or failed to make a decision or finding required by HUD regulations at 24 CFR part 58; (c) the grant recipient or other participants in the development process have committed funds, incurred costs or undertaken activities not authorized by 24 CFR Part 58 before approval of a release of funds by DCED; or (d) another Federal agency acting pursuant to 40 CFR Part 1504 has submitted a written finding that the project is unsatisfactory from the standpoint of environmental quality. Objections must be prepared and submitted in accordance with the required procedures (24 CFR Part 58, Sec. 58.76) and shall be addressed to Department of Community and Economic Development, Center for Community Building, 4<sup>th</sup> Floor, Commonwealth Keystone Building, Harrisburg PA 17120-0225 or emailed to Christine Howe at [chrhowe@pa.gov](mailto:chrhowe@pa.gov). Potential objectors should contact DCED to verify the actual last day of the objection period.***
